Risks of Farm Educational Activities

I understand and acknowledge that:

- Farms are inherently dangerous workplaces.
- Farm equipment and machinery can be hazardous if not used properly.
- Farm equipment is dangerous and should not be touched without permission.
- Out-of-bounds areas are clearly marked and should not be entered at any time.
- Wellington Point Farm Collective (WPFC), encompassing WPFARM Pty Ltd and WPFH Pty Ltd, and including its employees, partners, volunteers, and assigns, has provided safety instructions which I understand and will follow.
- It is important to wash hands frequently, especially before eating, to maintain hygiene.
- There is a risk of serious injury, death, or accident associated with farm educational and leisure activities.
- I have voluntarily read this warning, understood its content, and accept all inherent risks associated with participating in farming educational and leisure activities at Wellington Point Farm Collective.

Responsibility

I understand that:

- Participants must not engage in any farm activities while under the influence of alcohol or drugs.

Supervision

Children under 16 years old must be accompanied and supervised by an adult at all times.

Medical Treatment Consent

I hereby consent to receive medical treatment that may be deemed advisable in the event of injury, accident, or illness during any farm educational and leisure activities.

Other Requirements

- Vehicles are parked at the owner's risk. WPFC will not be responsible for loss or damage to any vehicle or its contents.
- Smoking is not permitted on the grounds of Wellington Point Farm.
- Appropriate footwear and clothing must be worn at all times.
 - o Fully enclosed shoes are required for safety.
 - o The red dirt can stain clothing, so we recommend taking this into consideration as participants will be invited to participate in the interactive crop gardens.
 - o Hats and sunscreen are required for sun safety.
- Further specific restrictions may be displayed throughout the venue via signage or staff communication, which must be obeyed.

Acknowledgment and Assumption of Risk

Participants acknowledge that they:

- Have voluntarily read and understood this warning.
- Accept and assume all the risks inherent or otherwise associated with participating in farm activities.
- Understand that they can choose not to participate in any activity if they feel it is too dangerous.
- Understand that WPFC provides educational and leisure activities and may photograph participants. They agree to allow their photo, video, or film likeness to be used for legitimate purposes by WPFC.
- Will follow all instructions, directions, and safety advice given by WPFC staff.
